Please fax or email the DVER with the Evergreen DVER cover page to the corresponding equipment location state during Evergreen office business hour prior to the container/chassis in-gate. There will be no receipt confirmation replied to you.

3. Driver Vehicle Examination Report (DVER) Reminder:

If the chassis is a pool chassis, you need to report the DVER to Chassis pool management. If it is an Evergreen non-pool chassis, please fill out Evergreen DVER cover page with DVER (issued by FMCSA authorized personnel) and fax or email to Evergreen as below indicated by equipment location state.

If the DVER did not attach to the Evergreen DVER cover page, we will not consider this is a valid filling.
